

Connectivity plans for E-Rate eligible libraries and K-12 schools

Each AT&T Connected Bus for Education plan requires a compatible router or modem, sold separately. It provides an internet connection via Wi-Fi. This enables students, patrons, and other eligible users to access the internet for educational use while on a school bus or in a library bookmobile.

Select plans include access to AT&T 5G/5G+ service.¹ All plans include Standard Definition video streaming, and there are no roaming charges for using the plan in Canada and Mexico.²

Plus, you can choose a plan with AccessMyLAN from AT&T included at no extra charge. AccessMyLAN from AT&T helps secure your internet connection with features that let you manage access to websites, filter restricted content, and manage mobile devices.³

ALL AT&T CONNECTED BUS FOR EDUCATION PLANS: Available only to eliqible K-12 schools and libraries with a primary place of use in the United States (Domestic Coverage Area or DCA) with a qualified wireless service agreement that includes, without limitation, an AT&T E-Rate Rider (Qualified Agreement). For Corporate Responsibility User (CRU) lines of service only. Plans are intended to provide Internet connectivity on (a) school district-operated buses for educational use by students, teachers and school administrators while traveling to or from school and while traveling for school-related activities during the academic school year and (b) on library-operated bookmobiles for educational use by students, patrons, and library personnel. All wireless services are subject to the terms and conditions of your Qualified Agreement. PRICING: Monthly price includes a monthly plan charge (\$29.99) for data service only. Each plan is limited to one line and requires a compatible wireless router or modem (sold separately) used on a qualified bus. Qualified Agreement Discounts: Plans are not eligible for any CRU service discount described in your Qualified Agreement.
