## Connectivity plans for E-Rate eligible libraries and K-12 schools

Each AT&T Hotspot for Education plan requires a compatible mobile hotspot device, sold separately. It provides an internet connection for educational use by students, patrons, faculty, and other eligible users.

Select plans include access to AT&T 5G/5G+ services.<sup>1</sup> All plans include Standard Definition video streaming, and there are no roaming charges for using the plan in Canada and Mexico.<sup>2</sup>

Plus, you can choose a plan with AccessMyLAN from AT&T included at no extra charge. AccessMyLAN from AT&T helps secure your internet connection with features that let you manage website access, filter restricted content, and manage mobile devices.<sup>3</sup>

Prefer to bring your own filtering solution? Simply choose a plan without AccessMyLAN.

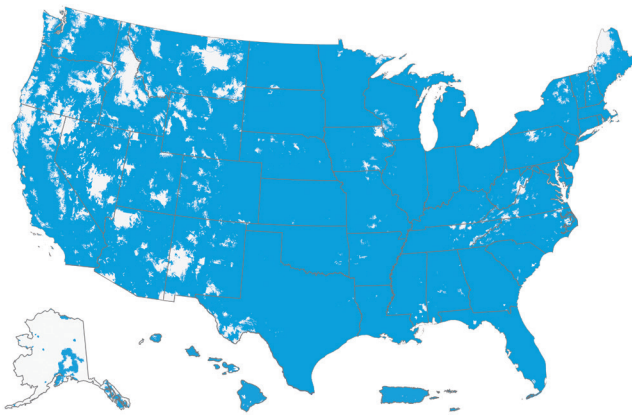
